Memorandum of Understanding

Between

Savitribai Phule Pune University, Pune

And

Youth4Jobs Foundation, Hyderabad

For providing market linked employment solutions to the most vulnerable and neglected, the Persons with disability (PwDs). This agreement is entered into between Savitribai Phule Pune University, Pune (herein-after to be called 'THE FIRST PARTY') and Youth4Jobs Foundation (Y4J) registered under Corporate Identity No. U80901AP2012NPL078912 incorporated under Sec 25 of The Companies Act, 1956 (No:1 of 1956) having its office at Plot No 135, Ave 2, Road No 13, Banjara Hills, Hyderabad – 500034 (here-in-after to be called 'THE SECOND PARTY')

Whereas it has been the concern of both the parties to facilitate the PwDs youth to get jobs/be self-employed and to mentor social entrepreneurs to shift the PwDs from unemployment to meaningful employment. Both the parties are committed to the cause of PwDs and believe that there is a large scope for each one of them to work together on this project.

Background

Youth4Jobs launched a program "Y4J IT Academy – A Smart Inclusion Center" which collaborated with Colleges/Universities/Institutions to orient and to link candidates with disabilities to IT jobs.

The objectives of this MoU

The aim of this agreement is to provide IT training and placement for candidates with disabilities. For the said purpose, the Youth4Jobs domain expertise in education services for students with disabilities will be shared.

The collaboration will focus on:

1. Organizing awareness and orientation programs 'on disability' to the Faculty of University, Colleges and School Teachers.
2. Providing training to candidates who are in the final year of higher education for employability and place them in appropriate jobs.
3. Organizing transition campus and training programs for candidates with disabilities completed higher education.

In pursuance thereof, the organizations have decided to sign a MOU in writing their roles and responsibilities towards fulfilling the above said objectives

The Roles of both the parties shall be as follows:

Role of the First Party

Making available training infrastructure for the training program of Youth with Disabilities in Pune, which includes:

- 1 Accessible Computer lab with capacity for 30 computers. Electricity Plug points, Network and Internet Connection for each computer
- 1 Accessible Classroom with a seating capacity for 30
- 1 seating room for 6 people
- Wi-Fi Facility
- The rooms shall be available 6 days a week for full day

Role of the Second Party

- Mobilise the Youth with Disabilities for the training program - 250 youth over 2 years
- Train the youth in IT skills, link them to placement and support them in post placement.
- Pay salaries to the trainers of Youth4Jobs who will be employed for this purpose.
- Investment on purchasing / renting of desktops and maintenance of desktops and laptops in the computer lab
- Investment on purchasing/ renting projector and it's maintenance in the classroom and computer lab

Program Manager

For effective implementation and monitoring of the program as envisaged in the MoU, Rajiv Nair, Project Manager - College Connect shall represent Youth4Jobs Foundation

Project Executives and Trainers

For training and coordination, Youth4Jobs will appoint 2 educators and a sign language interpreter for whom the salary will be paid by Youth4Jobs Foundation.

Term and Renewal:

This agreement shall remain valid initially for a period of 3 years from the date of execution hereof. Any renewal thereafter must be expressly agreed in writing by both parties failing which this agreement shall be deemed to have end by efflux of time. This agreement may be terminated by either party giving one month written advance notice to the other, if required. Both the organizations shall not use logo, emblem or brand name of either in their advertisements, pamphlets or brochures or websites without the written permission of the Head of the organizations.

Resolution of Disputes: the parties agree to resolve any differences or disputes arising from this agreement by mutual discussions.

Legality and Ethics: Both parties agree to observe highest standards of legality and ethics.

All the terms and conditions of this MoU are subject to the approval of the various bodies of the University and the provisions of the Rules and Regulations of the University.


The parties are at liberty to amend the clause under this agreement by mutual consent.




