The University hosts Regional cum facilitation centre Western region sponcered by the National Medicinal Plants Board and a Centre of excellence in Ayurveda sponcered by the Ministry of Ayush, Government of India. These centres are doing research, development and taking care of teaching activities in the respective subjects. University is conducting many other courses on IKS involving Yoga, Meditation etc. Further university is geared up to inplement NEP 2020 from 2023-24 academic year. The courses on IKS will be thus part of NEP syllabi and the course content delivery will be done in regional languages as per NEP guidelines.

Also students participate in environment friendly activities like plantation of trees, rainwater harvesting through Student welfare and development board and Learn and earn schemes on the campus. The process is fully transparent and well documented. Thus the complete continuous process ensures the contemporariness of curriculum and also its effective implementation to achieve the

programme objectives.

2.2 - Catering to Student Diversity

2.2.1 - The institution assesses the learning levels of the students and organises special Programmes for advanced learners and slow learners

The University has a formal mechanism of continuous assessment in the choice based credit system. The mechanism that classify the advanced learners from the slow learners is based on the performanceof students in the internal and external examinations in the continuous assessment process. The syllabi designed for various courses have optional advanced courses that fast learners can opt for. Similarly, advanced learners are provided with professional/application oriented/higher skill developing courses to meet there learning needs. Students are also encouraged to join courses offered on SWAYAM portal for advanced learning in specialised subject areas. The slow learners on the other hand are provided with bridge courses/off the class discussion forums conducted by the teachers. English language proficiency courses are specially conducted for International and Indian students both to overcome language barriers and enhance the pace of their learning. Every student enrolled to the campus courses, is provided with a mentor who understands and takes care of personalized learning needs of slow and fast learners and fine tune the modes of content delivery for them.

2.3 - Teaching- Learning Process

2.3.1 - Student centric methods, such as experiential learning, participative learning and problemsolving methodologies are used for enhancing learning experiences

The University teachers after their appointment to the campus departments have to undergo an orientation program of 28 days which principally teaches them the various pedagogies and assessment methodologies. The Student centric learning methods, such as experiential, participative and problem-solving learning are thus regularly used by the teacher of campus departments in their regular teaching process to enhancing learning experiences of students.

Fourquadrant learning, i.e. LeD (Learning Dialogue), LbD (Learn by Doing), LxT (Learning Extension Trajectories) LxI (Learner experiential Interaction) are used by teachers to conduct the teaching process. Thus the teaching process in campus departments include, questioning during content delivery, practical based learning, provided reference material after content delivery and discussion forums regulated by moderators to enhance learning experiences of slow and fast learners. Every teacher is given the freedom to use the best pedagogy for their course. For instance, enhanced learning experiences for Science studentsis though laboratories, for students of humanities is through field projects and for commerce and management its through internships. These activities are integrated in the syllabi and thus acquisition of knowledge is tested through practical performance or viva-voce exams.

2.3.2 - Teachers use ICT enabled tools including online resources for effective teaching and learning processes during the year

ICT enabled tools have been used by some teachersfor a long time. However, the pandemic period, ensures that all teachers accepted technology as an integral part of teaching and learning process. Teaching for the academic year 2020-21 remained a combination of predominantly online and scantily offline mode. The online mode of teaching required use of technology platforms, such asGoogle-Meet, Zoom, Microsoft-Teams which were tried, tested and effectively implemented by all the faculty members in the regular teaching process. Anothertool for effectively teachingthe students was the YouTube. Teachers of campus departments developed their own private YouTube channels and hosted their Video lectures for restricted or open use for students. The University's e-content portal initiative was appreciated by all the faculty members of campus and affiliated college teachers and they contributed to developmontent forthis portal, continuing the learning process uninterruptedduring the pandemic period. The University subscribed a Learning Management System, Moodle, andwas quickly accepted by the teachers for teaching and conducting examinations. The use of proctored method provided by the Moodle LMS, helped in maintaining sanctity and spirit of the University examination. ICT tools have become an inseparable part of the teaching learning process.

The University has an ecosystem to promote research and development in all disciplines. Apart from the departmental experimental and computational labs, the University has established a Central Instrumentation facility (CIF) that hosts the state of the art equipment required to undertake the research in the frontier areas. The equipments are well maintained and are updated regularly at CIF. These equipments are made available to the faculty members of the campus departments and affiliated colleges and any other academic institutionsto undertake research in affordable costs. The University also has a research funding scheme namely, ASPIRE to support the young faculty members of the campus departments and affiliated colleges. The University Research Park facilitates incubation of commercially viable research ideas. University has conducted various environmental awareness activities such as tree plantation, Water Harvesting System, Solid waste management systems, promoting the use of cycles, Energy Efficient Lighting, bioremediation and other related activities in different places of Pune, Ahmednagar and Nashik districts which come under the jurisdiction of SPPU. Heaps of scrap and waste item lying around Savitribai Phule Pune University was nothing but an 'eyesore' for the visitors. However, the same waste made the university over Rs 1 lakh. The Savitribai Phule Pune University (SPPU) started a cleanliness drive in the Jan 2020 and received an unexpected response from the vendors. The waste collected is collected from the campus' buildings, segregated, and auctioned the same. The team collected and segregated almost 100 truckloads of waste. An online

auction was conducted to ensure proper waste management. Now, the items are being dispersed and taken away by the vendors. He also added that around five tonnes of electronic discard and eight metric tonnes of electrical waste were purchased by vendors for around Rs 73,000 and Rs 35,000 respectively.

The mechanism that classify the advanced learners from the slow learners is based on the performance of students in the internal and external examinations in the continuous assessment process. The syllabi designed for various courses have optional advanced courses that fast learners can opt for. Similarly, advanced learners are provided with professional/application oriented/higher skill developing courses to meet there learning needs. Students are also encouraged to join courses offered on SWAYAM portal for advanced learning in specialised subject areas. The slow learners on the other hand are provided with bridge courses/off the class discussion forums conducted by the teachers. English language proficiency courses are specially conducted for International and Indian students both to overcome language barriers and enhance the pace of their learning. Every student enrolled to the campus courses, is provided with a mentor who understands and takes care of personalized learning needs of slow and fast learners and fine tune the modes of content delivery for them.

2.3 - Teaching- Learning Process

2.3.1 - Student centric methods, such as experiential learning, participative learning and problemsolving methodologies are used for enhancing learning experiences

The University teachers after their appointment to the campus departments have to undergo an orientation program of 28 days which principally teaches them the various pedagogies and assessment methodologies. The Student centric learning methods, such as experiential, participative and problem-solving learning are thus regularly used by the teacher of campus departments in their regular teaching process to enhancing learning experiences of students. Fourquadrant learning, i.e. LeD (Learning Dialogue), LbD (Learn by Doing), LxT (Learning Extension Trajectories) LxI (Learner experiential Interaction) are used by teachers to conduct the teaching process. Thus the teaching process in campus departments include, questioning during content delivery, practical based learning, provided reference material after content delivery and discussion forums regulated by moderators to enhance learning experiences of slow and fast learners. Every teacher is given the freedom to use the best pedagogy for their course. For instance, enhanced learning experiences for Science studentsis though laboratories, for students of humanities is through field projects and for commerce and management its through internships. These activities are integrated in the syllabi and thus acquisition of knowledge is tested through practical performance or viva-voce exams.

External audits are conducted by Statutory Body (Reputed Chartered Accountant Firm) appointed by the Management Council. As per Ordinance 151, Supervisory officers conduct pre-audit of all purchases/work orders, bill before they are issued and paid respectively. Heaps of scrap and waste item lying around Savitribai Phule Pune University was nothing but an 'eyesore' for the visitors. However, the same waste made the university over Rs 1 lakh. The Savitribai Phule Pune University (SPPU) started a cleanliness drive in the Jan 2020 and received an unexpected response from the vendors. The waste collected is collected from the campus' buildings, segregated, and auctioned the same. The team collected and segregated almost 100 truckloads of waste. This facility is extended to all the universities, academic institutes, national research institutes, defense institutes, and industries in India. E-content development and Learning innovation centre catered to the need of students for online/ digital contents for learning and for faculty to reach out to masses. Centre for Innovation, Incubation Linkages C-BRIDGE (Center for Business, Research, Incubation, Development, Growth and Entrepreneurship) has been set up to promote innovative start-ups through the University ecosystem. Centre would facilitate the movement of ideas from laboratory bench to commercial level. Educational Multimedia Research centre (EMRC): Developing MOOCs Courses for UG and PG subjects since June 2019. For this, 25 auto rickshaw drivers have been trained by the IMA to handle oxygen equipment.

The University will establish initiate the research in Centre for Molecular Diagnostic and Research. A unique program using the online platform "Degree Plus" to provide desired updated skill and knowledge to make students industry isplanned. Milestone International Education (MIE) licensed by the Ministry of Higher Education (MoHE), Qatar signed MoU with SPPU and will enable SPPU to become the first Indian State University to start a campus in Doha, Qatar. In collaboration with Indian Air Force, the University plans to establish a "Chair of Excellence" in the name of Marshal of the Indian Air Force Arjan Singh. The University plans to establish a Yoga chair for promoting Yoga education The sports complex and the indoor stadium will be completed and dedicated The University has proposed to erect Savitribai Phule Statue on campus.
