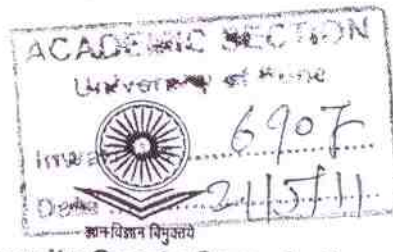



Dear

As you are aware, the National Commission for Scheduled Castes has been constituted under Article 338 of the Constitution of India for addressing the grievances of members of Scheduled Caste community. The members of the community have a legitimate right to approach the Commission.

2. In exercise of their legitimate right a number of persons belonging to scheduled caste approach the commission for redressal of their grievances. The Commission in turn takes up the matter with authorities concerned. At times the representation/complaint of the individual is forwarded to the authority concerned, in original.

3. It has been alleged that when the officials handling such subject come to know about the fact of the Commission being approached by some persons, they start further harassing the representations/complainant. The instances of such harassment included transfer to far away places or suspension etc. on flimsy ground.

4. Chairman, National Commission has taken a serious view of this trend of increasing harassment and approached Hon'ble Minister for HRD to instruct the officials under the administrative control of the Ministry to not to resort to such undesirable practices.

5. Though we in the Ministry are not aware of details of individual cases, the allegations if true are very serious and the individual concerned deserved corrective and punitive action.

6. I, therefore, request you to kindly look into the matter personally and issue strict instructions to the officials under your control to ensure that officials/officers belonging to Scheduled Caste are not harassed for approaching the Commission for protection of safeguards as provided in the Constitution of India.

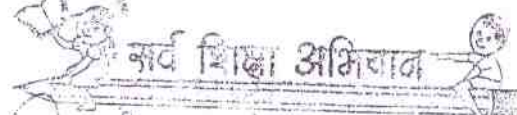
