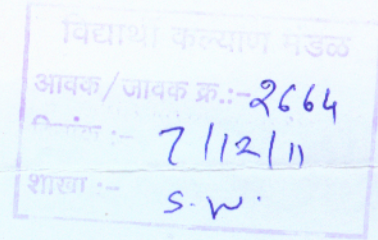

Details of other references, if any made should also be listed. The **last date for submission of the paper is 31st January, 2012**. The papers will be evaluated by a panel of experts on insurance set up by the Insurance Regulatory and Development Authority.

The following prizes shall be awarded:

1. First prize Rs.50,000
2. Second prize Rs. 30,000
3. Third prize Rs. 20,000

Only papers received at IRDA at the following address **on or before 31st January, 2012 by 5.30 PM** in physical form shall be accepted.
