**Admission Instructions for M.Sc. Computer Science
(A.Y. 2026–2027): Spot Round**

Notice for Admissions Spot Round:

Admissions will be held **in person** as per the schedule given below (after the instructions) at the **Department of Computer Science, Savitribai Phule Pune University, Pune – 411007**.

Only those candidates whose names appear in the general merit list will be considered for this round.

All candidates who are interested to participate in the Spot Round process are requested to remain present for the same. Kindly ensure timely reporting and complete readiness with the required necessary documents. Also note that fees must be paid online at the time of admission so ensure you have sufficient balance in the payment option you choose and adequate limits etc are properly set.

NOTE: The final vacancy position is provisional and subject to change. The number and category of vacant seats may be revised, including the conversion of seats from reserved categories to the Open category or vice versa, in accordance with the applicable admission rules, government regulations, and the verification of documents submitted by the candidates. Accordingly, the final allotment of seats shall be made strictly as per the prevailing rules and the verified eligibility of the candidates.

Failure to remain present at the scheduled time may result in forfeiture of their claim for admission, in accordance with the applicable rules and regulations.

General Instructions

- **Attending the Admission Round Does Not Guarantee Admission**
Merely attending the admission round does **not guarantee confirmed admission** to any course in the Department of Computer Science, Savitribai Phule Pune University.
- **No Travel or Daily Allowance (TA/DA)**
No TA/DA or other allowances will be provided for attending the admission process under any circumstances.
- **Eligibility Criteria**
Candidates must satisfy themselves regarding the eligibility criteria **before appearing** for the admission round. Ineligible candidates will be disqualified at any stage of the admission process.
- Failing to report for the admission round in time shall be considered as "Not Interested," and the concerned seat shall be processed accordingly as per SPPU rules and norms. Please refer to the reporting time given below.

- **Final Authority**

The **Department reserves the right to modify or cancel any admission** if any information or document is found to be false, forged, or misleading at any point in time. The decision of the Admission Committee shall be final and binding in all matters.

Required Documents (Original + 1 Self-Attested Copy)

Candidates must produce the following **original documents along with one set of self-attested photocopies** at the time of admission:

1. Self-Attestation Certificate
2. PH Certificate (if applicable)
3. H.S.C. (12th Standard) Marksheet
4. Bachelor's Degree Marksheets of all years (Original or duly attested copy for admission round only)
5. Caste Certificate (if applicable)
6. Maharashtra Domicile Certificate
(*Not required if the candidate has passed both S.S.C. and H.S.C. from Maharashtra*)
7. Non-Creamy Layer Certificate (if applicable)

Candidates claiming admission under a reservation category requiring a Non-Creamy Layer Certificate shall upload either

- **a valid Non-Creamy Layer Certificate (valid up to March 2027), or**
- **the latest acknowledgement/receipt issued by the competent authority as proof that they have applied for the issuance or renewal of the Non-Creamy Layer Certificate. However, such candidates shall produce a valid Non-Creamy Layer Certificate within the period prescribed by the Government, failing which their reservation claim shall not be considered. In the absence of a valid certificate, they may be considered for admission under the General Merit Category, subject to merit, eligibility, and availability of seats.**

8. Caste Validity Certificate (if applicable)
9. Valid EWS/SEBC Certificate (if applicable)
10. Sports/Defence/Orphan Quota Certificates (if applicable)
11. Gap Certificate/Change of Name (if applicable)
12. Migration Certificate (for students coming from other universities)
13. Transfer Certificate (TC)/Leaving Certificate from the previous institution

14. Equivalence Certificate from SPPU (if the degree is from a foreign university or if required)

Fee Payment Instructions

The **admission fee must be paid on the same day** of the admission round through the admission portal after the verification of all the relevant documents and eligibility criteria. The link will be provided at the time of admission.

 - All information submitted is true to the best of their knowledge.
 - They will abide by the rules, regulations, and code of conduct of the university.

All interested candidates should remain present at the reporting time and the admission process shall begin at 11AM on the round day.

Note that if two or more candidates obtain identical entrance examination marks, the Rank ID assigned to them is merely a sequential identifier and must not be construed as their order of merit. The final merit position among such candidates shall be decided strictly in accordance with the applicable tie-breaking criteria. Accordingly, it may occur that a candidate bearing a higher Rank ID is placed above one with a lower Rank ID in the merit list.

This page is subject to corrections/updates as the case may be, and the same shall be communicated to the concerned candidates upon updates.
